- Street teamers must "share" and post Marie May Carter's social content in a timely manner on their social media platforms with genuine comments. We require you to post any content we send you.
- Marie May Carter is not responsible for any injuries or accidents sustained, or caused, while working on street team duties, nor liable for any slander, mental or physical injuries or issues that may arise out of working with the Author Marie May Carter. You are a volunteer, not a paid employee of Marie May Carter. This is strictly a volunteer position. By agreeing to these terms set, you release and hold Marie May Carter harmless for any wrongdoing or medical treatment that may arise from your volunteer service.
- In return for your promotional services, you will receive Marie May Carter's book free of charge. Therefore, the following NDA is accepted upon sending the form through the abovementioned website.

Street Team Member Nondisclosure Agreement

This Nondisclosure Agreement (the "Agreement") is entered into by and between Marie May Carter ("Disclosing Party," "Company," or "Editor") and the person(s) entrusted with reading and promoting Marie May Carter's work in return for a promotional Street Team Member task ("Receiving Party," or "Street Teamer") for the purpose of preventing the unauthorized disclosure of Marie May Carter's ("Author") Confidential Information as defined below. The parties agree to enter into a confidential relationship with respect to the disclosure of confidential information ("Confidential Information").

- 1. DEFINITION OF CONFIDENTIAL INFORMATION. Any Author's work received for the purposes of street teaming, whether it be in electronic or in hard-copy form and a full manuscript or an excerpt. Also, any information given by email, post mail, or any other means of communication.
- 2. EXCLUSIONS. If an Author has published the work that Street Teamer has been asked to beta read, Street Teamer will be allowed to speak (verbally or electronically) with members of the public regarding the work but not physically or electronically share it, unless a physical copy has been freely given as a gift from the Author or legally purchased from a book retailer or, if an electronic version, purchased from a physical or digital book retailer (through which the Author has legally given permission to share the work). The Street Teamer has permission to post a review on book review websites (e.g. Amazon, Goodreads) after the Author has approved the review. The Street Teamer has permission to speak with the Author regarding Author's work.
- 3. The Street Teamer agrees and confirms that any and all work submitted to them from Marie May Carter is the rightful intellectual property and copyrighted material of the Author. The submission of material for beta reading and/or editing privileges made exclusively under this agreement is in no way to be represented as purchased property.
- 4. The Street Teamer agrees that under no circumstances will they redistribute, copy (either electronically or physically), share, or make public any material in any size or quantity to any third party outside of this Agreement. The Street Teamer understands that this includes but is not limited to

piracy, speaking about manuscript contents with anyone other than the Author, and duplicating the manuscript in any form.

- 5. LEGAL PROTECTION BY GOVERNING LAW. This Agreement shall be upheld by the legal authority (court) that presides over the Author's and the Street Teamer's state and/or country of residence. The Author has the right to prosecute any and all violations of the Agreement by any legal means available.
- 6. LIABILITY. Street Teamer is solely responsible for any violation of this Agreement. Marie May Carter will not be held liable for Street Teamer's actions.
- 7. LENGTH OF AGREEMENT. This Agreement will be valid indefinitely, unless otherwise specified in writing and signed by both parties, even in the event Street Teamer is no longer associated with Marie May Carter.
- 8. This Agreement is in relation to the Street Teaming of the provided, unfinished, unpublished manuscript and any other related material submitted to the Street Teamer.
